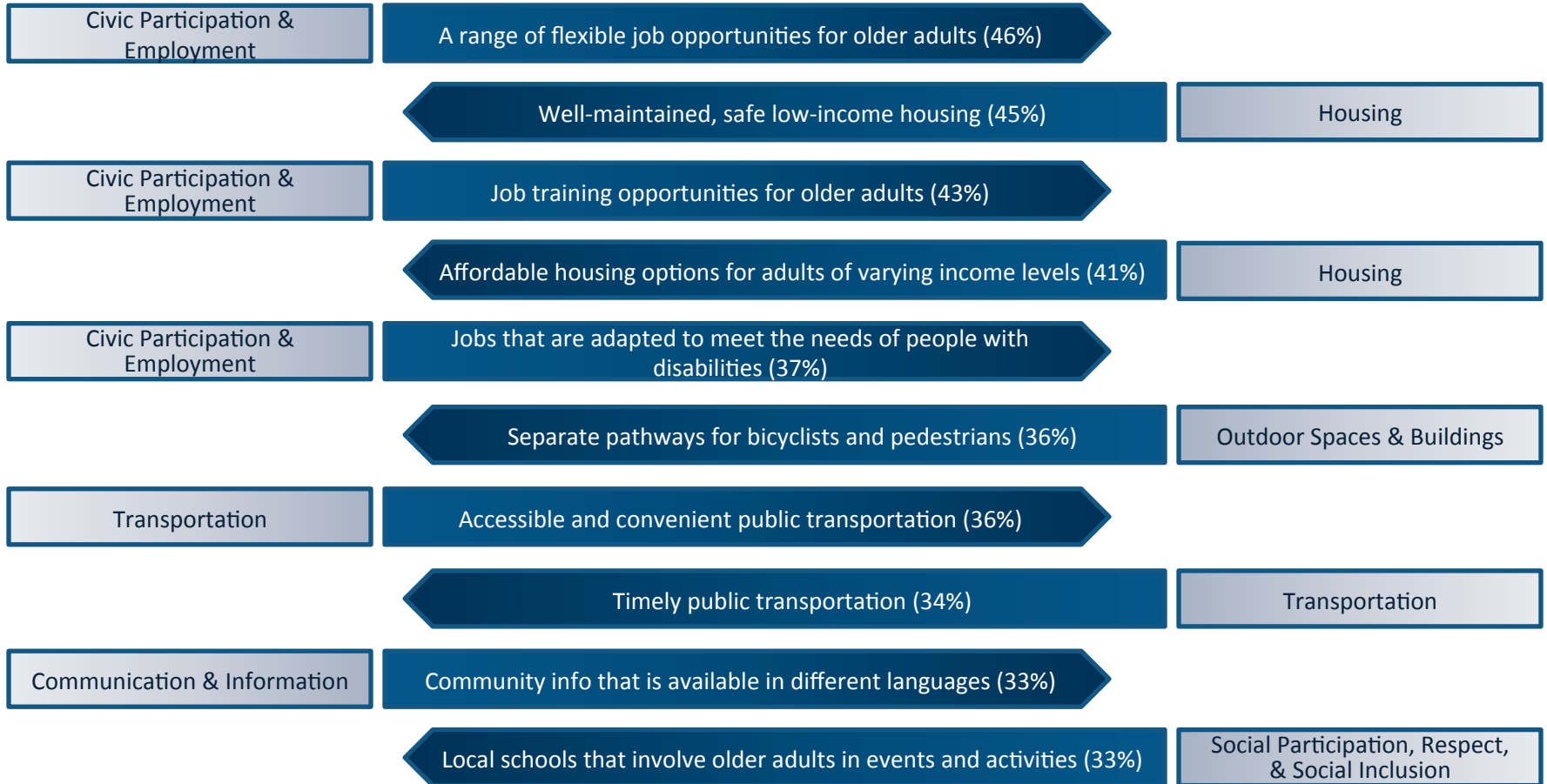

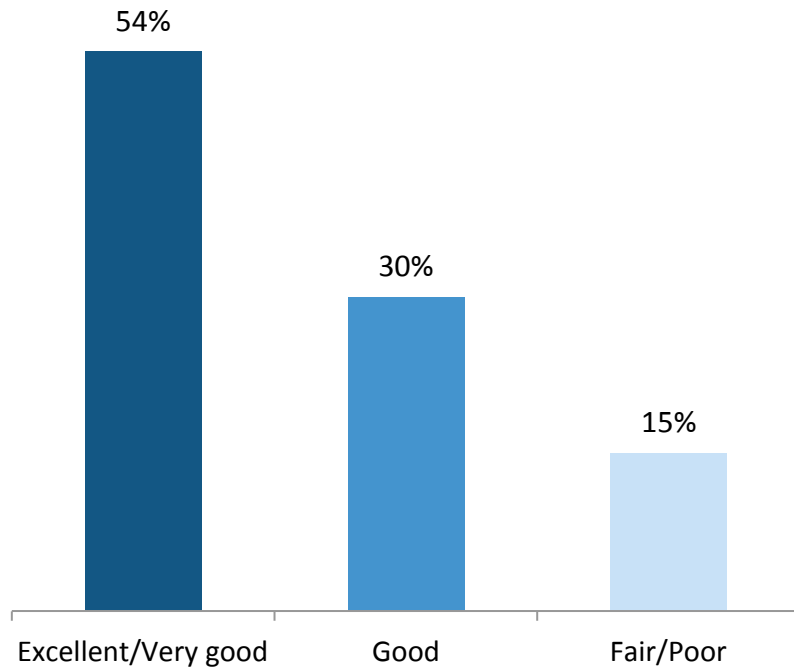

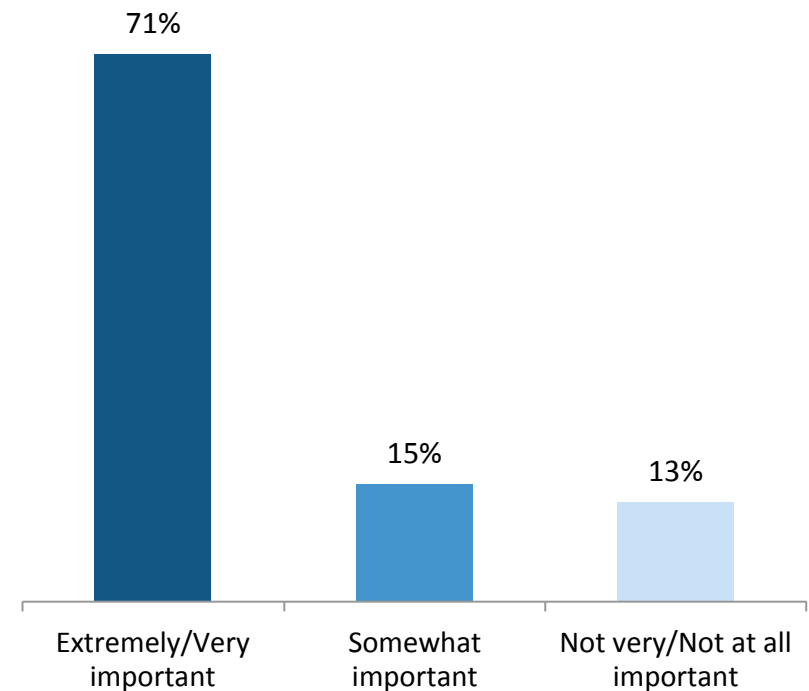

as a Place for People to Live as They Age



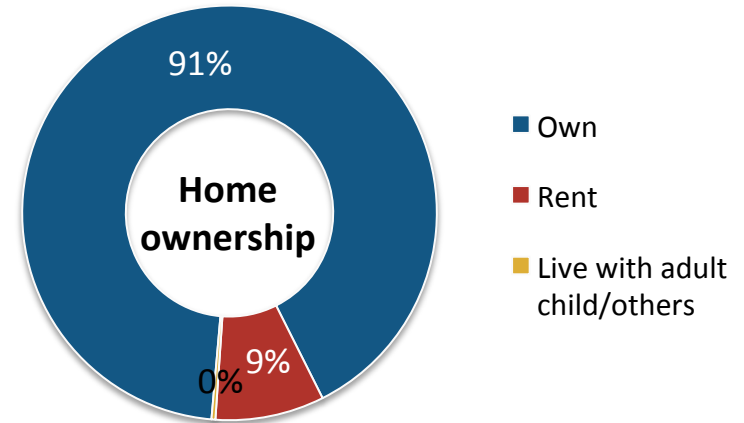
Importance of

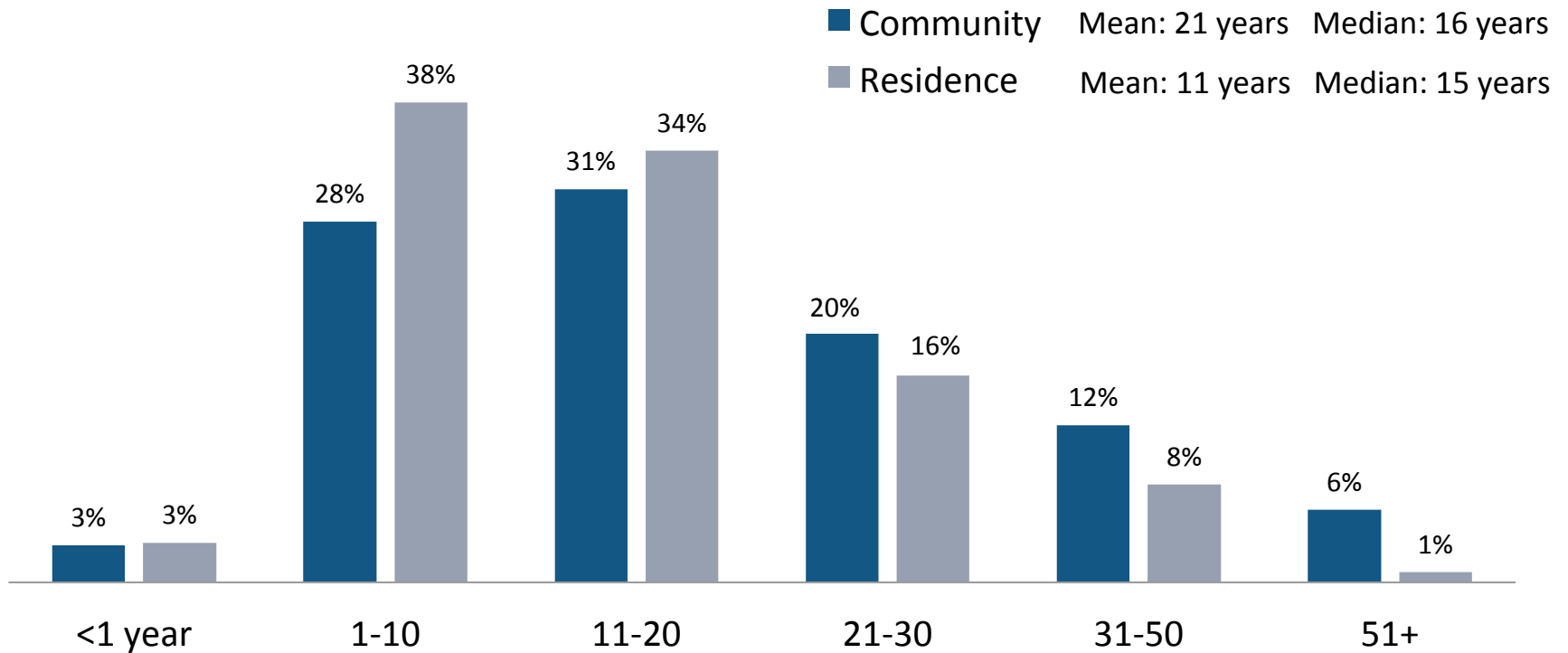


14% of respondents say they need to make major repairs, home modifications, or changes

Larimer County residents age 50+ have lived in their home for an average of 11 years and have lived in their community even longer, an average of 21 years.



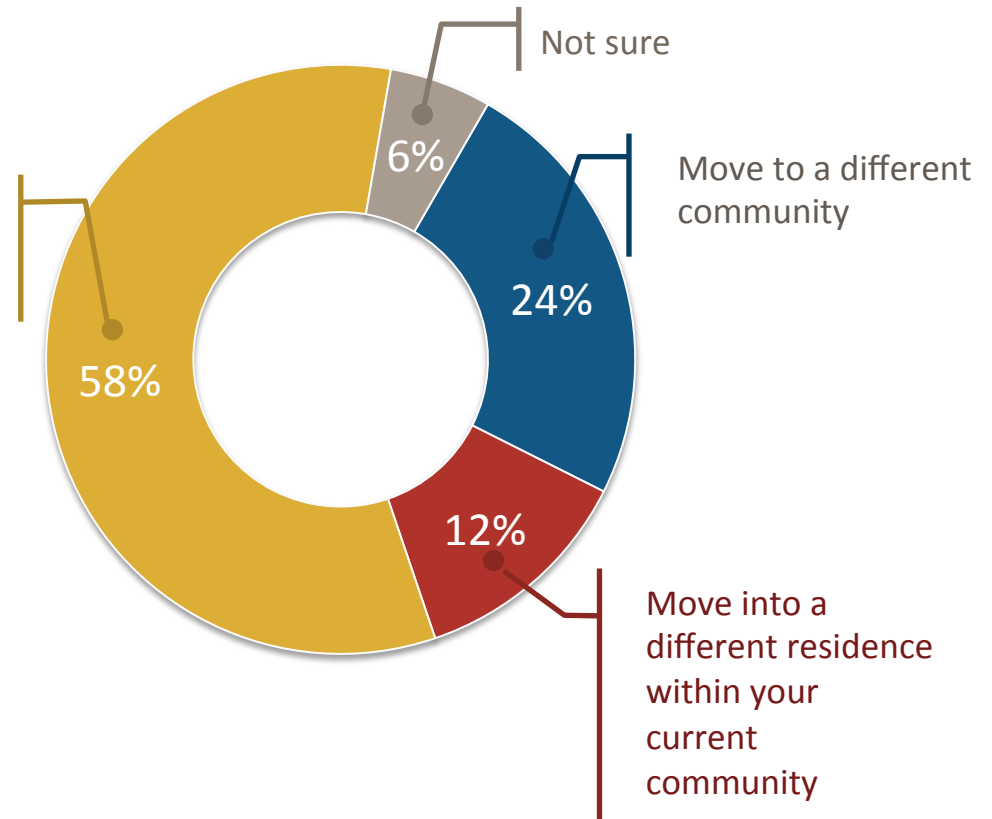

The majority of Larimer County residents age 50+ expect to stay in their home or community as they get older.



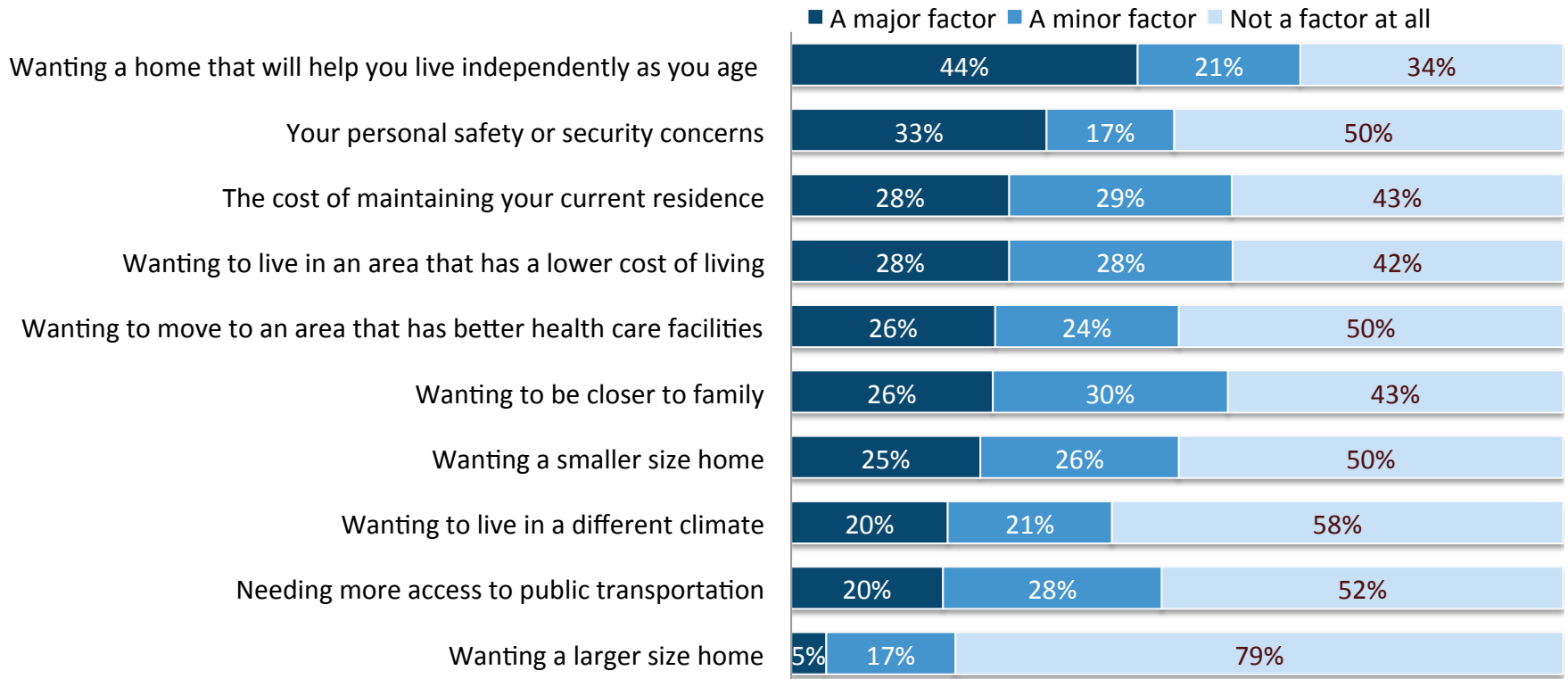

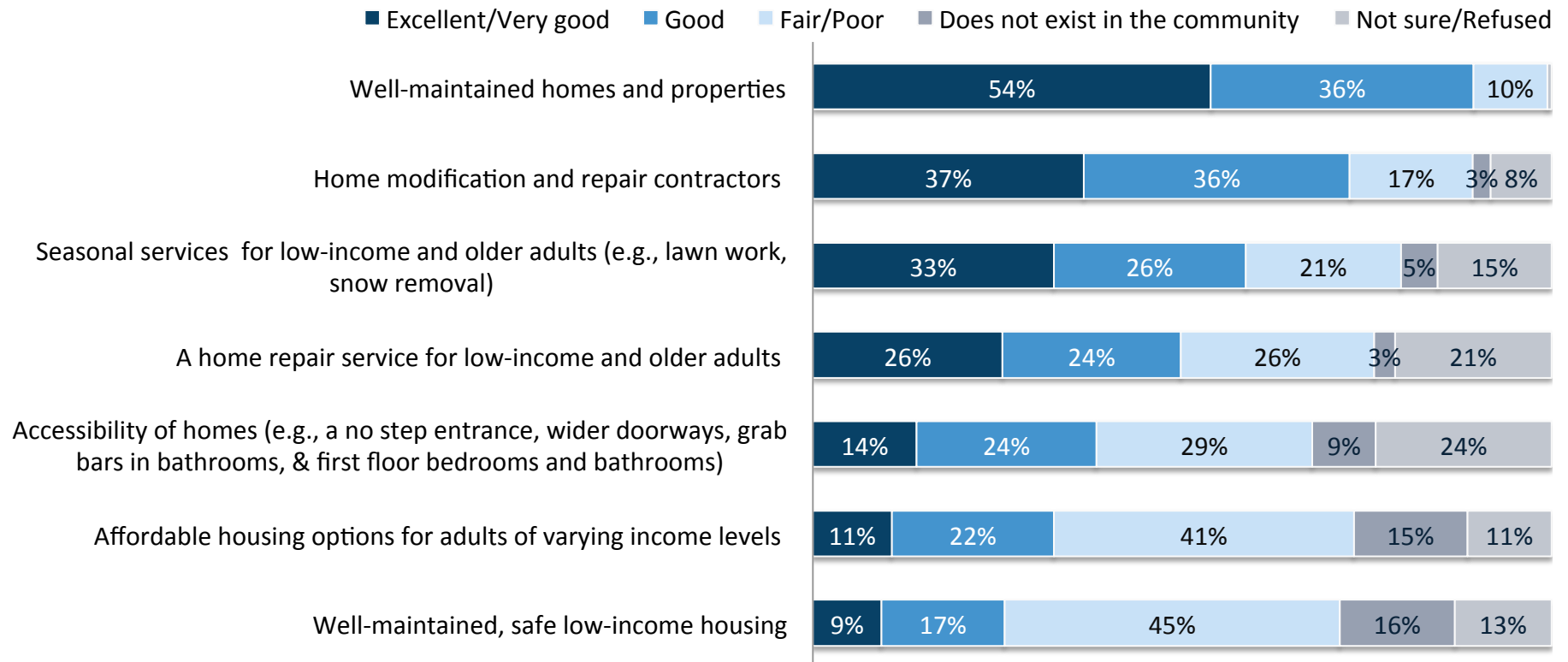
Age-friendly housing, safety, affordability, health care facilities, and wanting to be closer to family are influential factors for Larimer County residents age 50+ considering moving when they get older.

Larimer County residents age 50+ rate their community positively on having well-maintained homes and properties as well as good home modification and repair contractors.

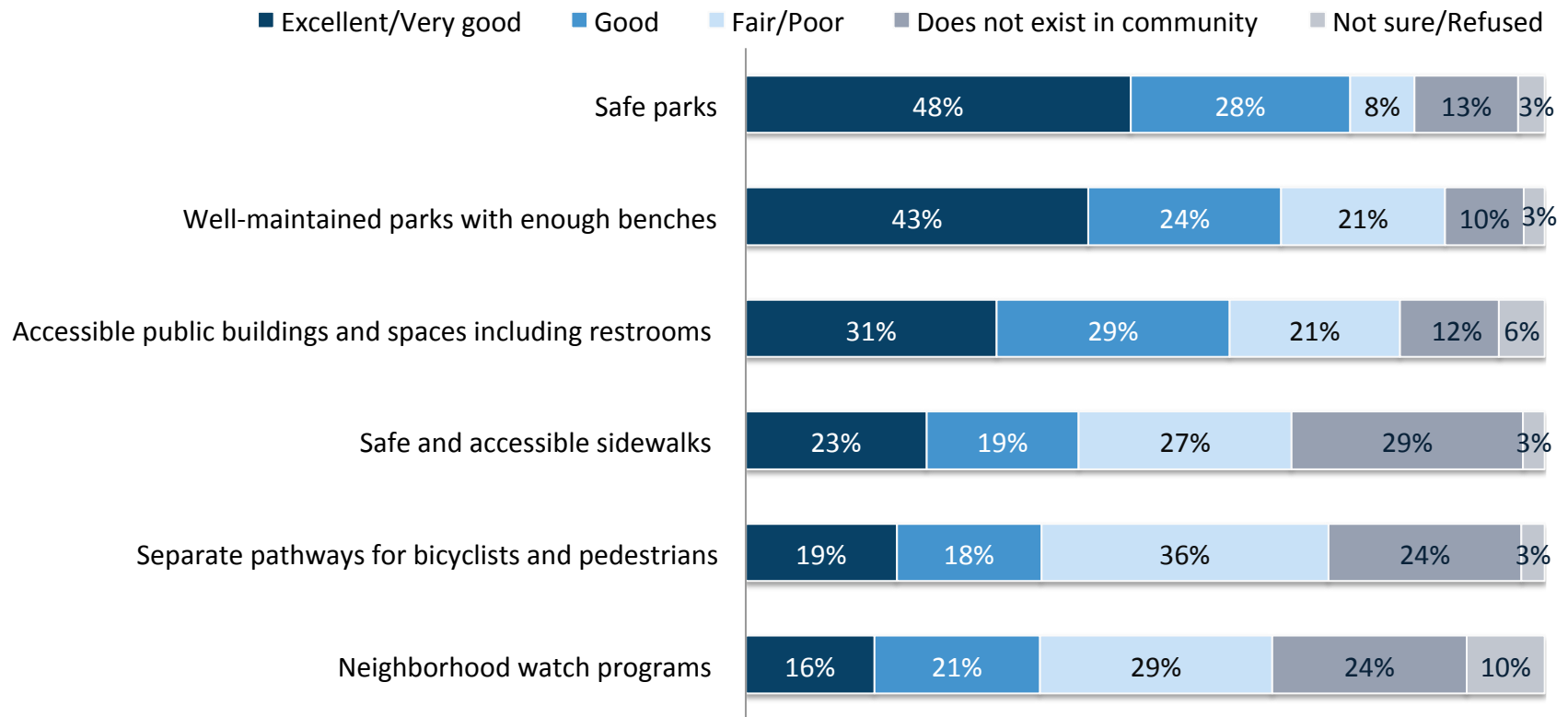

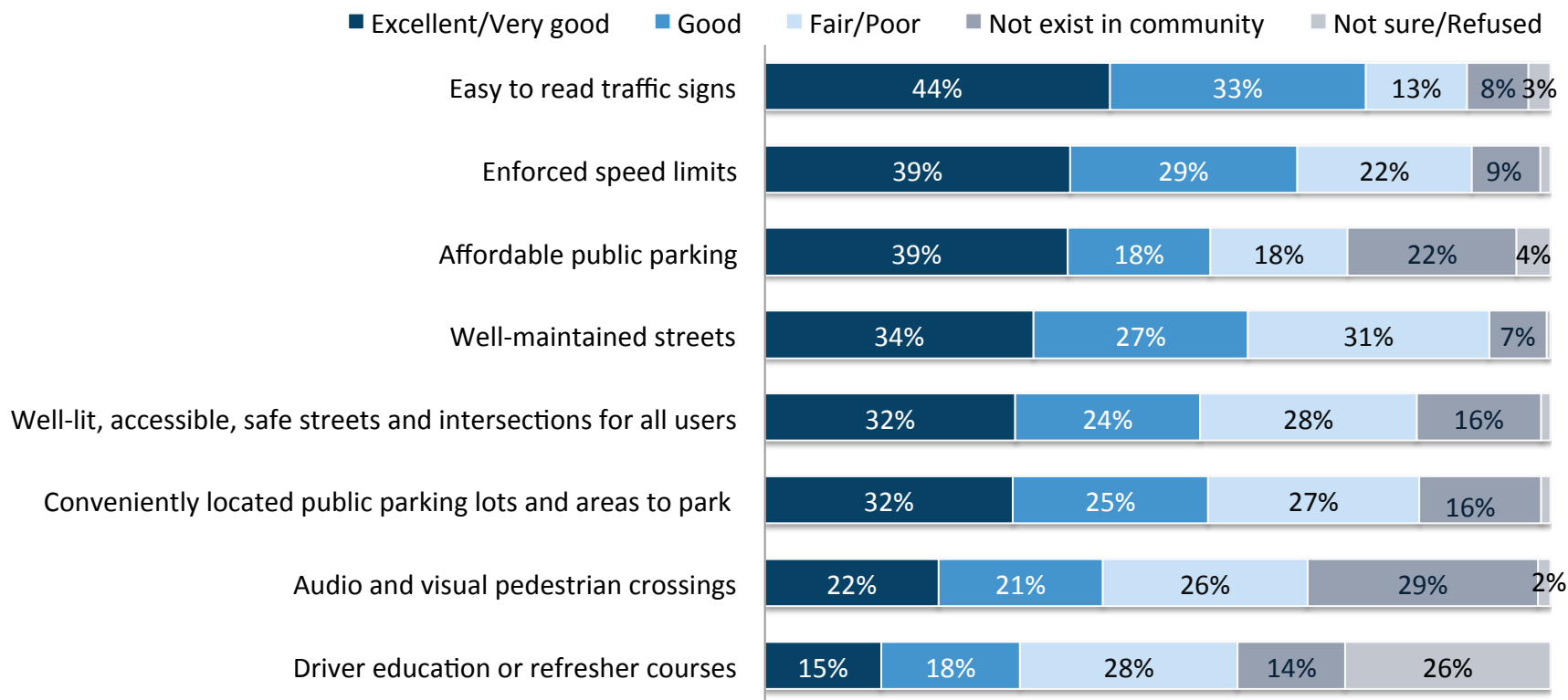

Larimer County residents age 50+ rate their community excellent to good on having easy to read traffic signs and enforced speed limits.

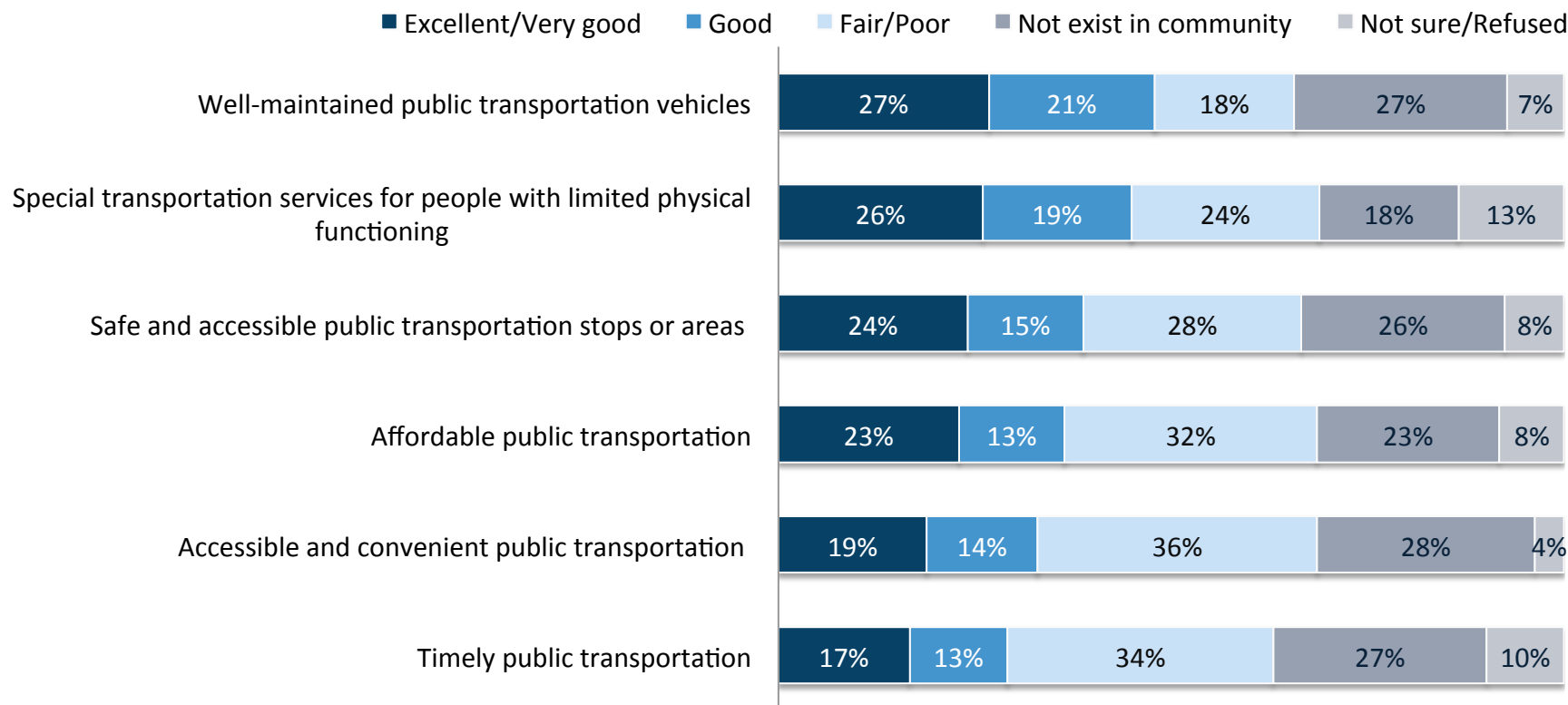

About half of Larimer County residents age 50+ feel their community offers excellent to good well-maintained public transportation and special transportation options.



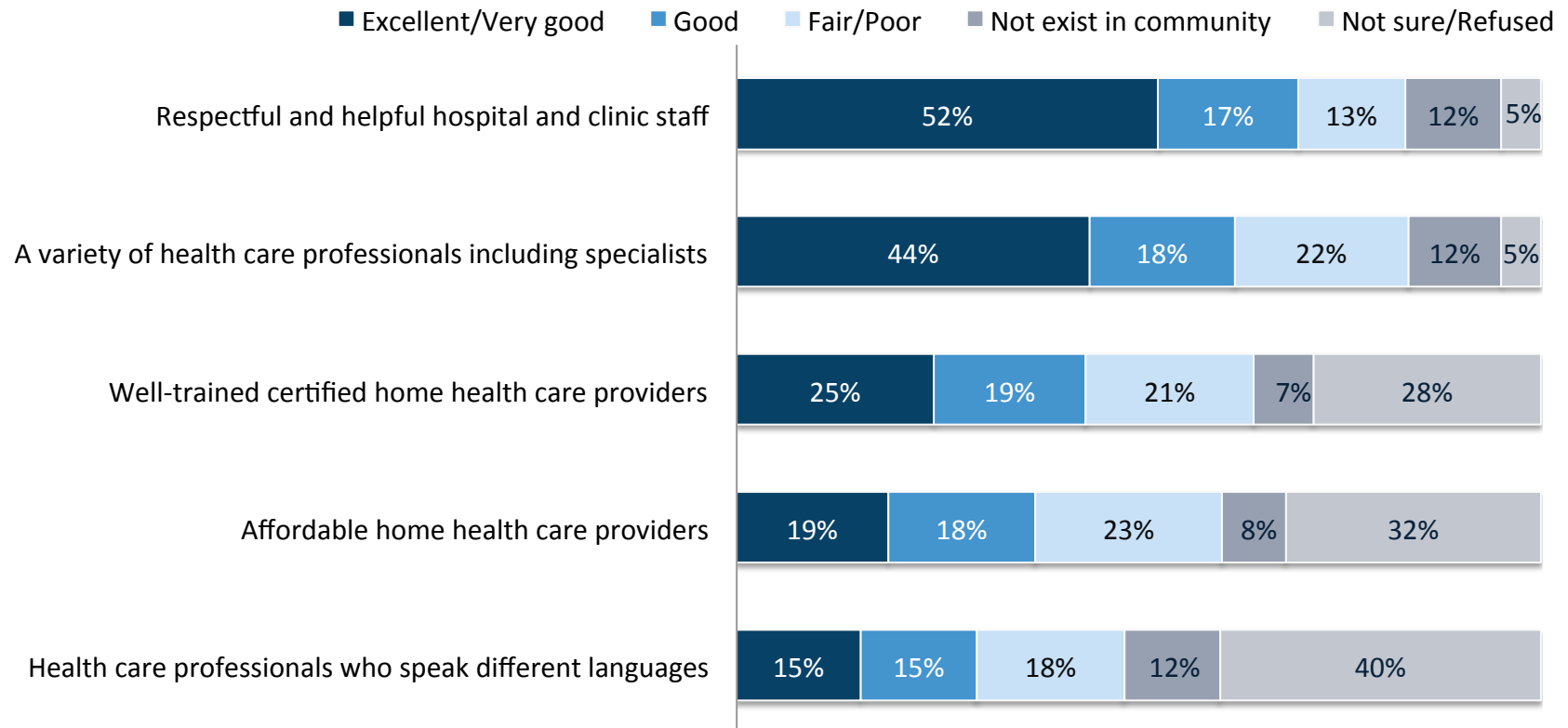

The majority of Larimer County residents age 50+ rate their community excellent to good on having a variety of helpful and respectful health care professionals.



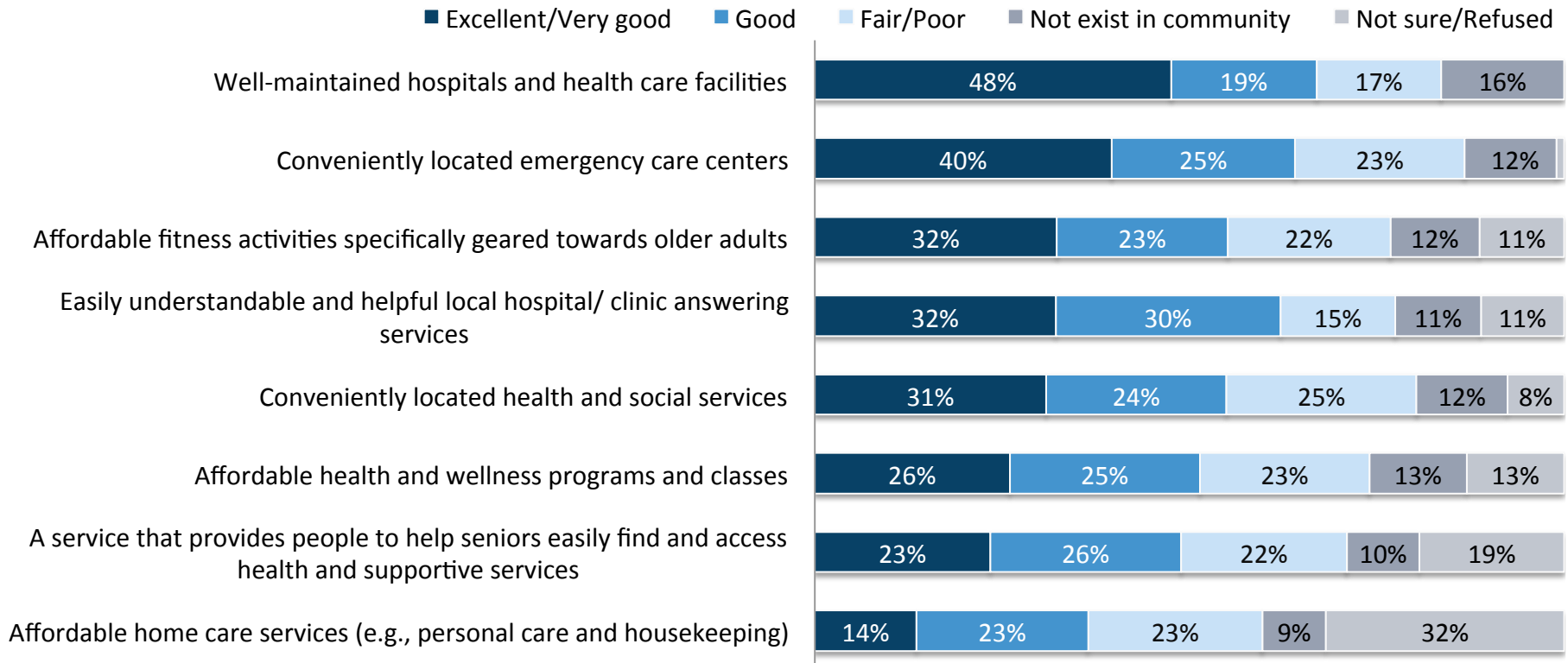

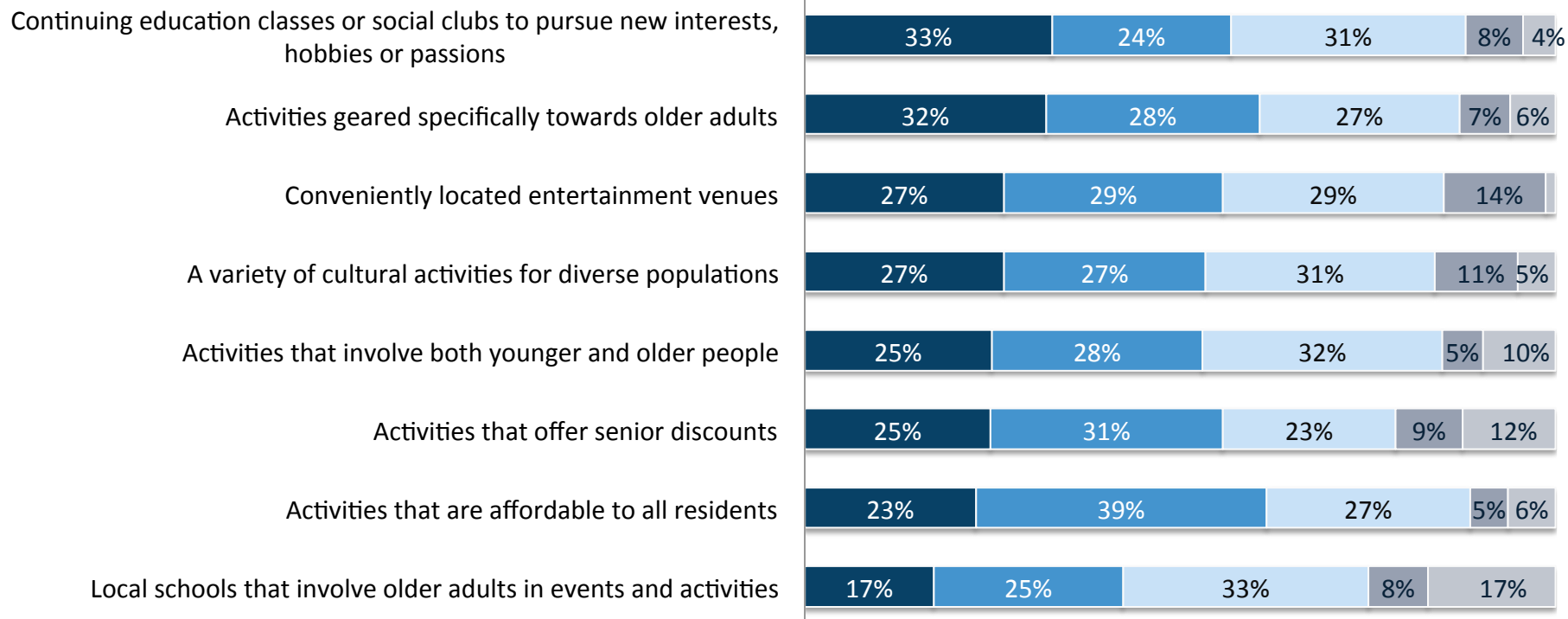

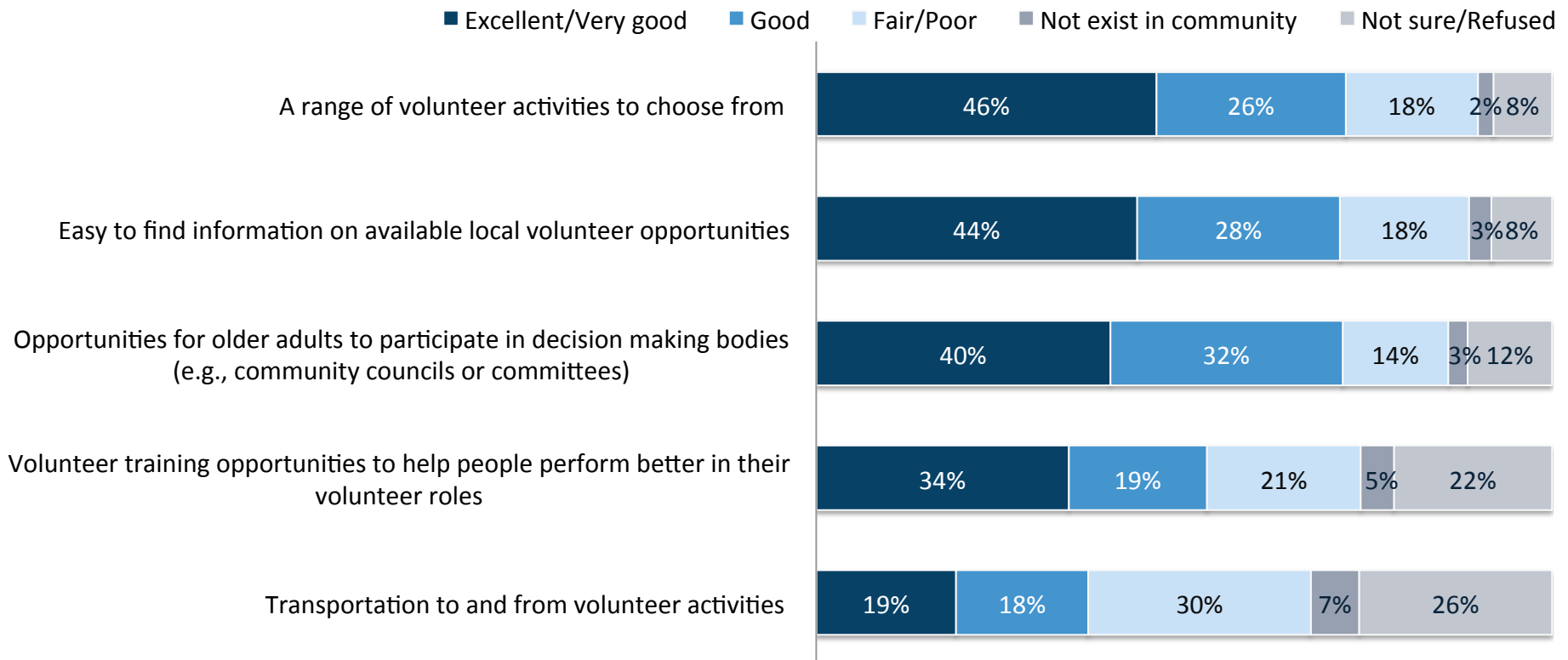

The majority of Larimer County residents age 50+ rate their community positively on having access to a variety of volunteer activities although a plurality give a negative rating on having volunteer transportation.

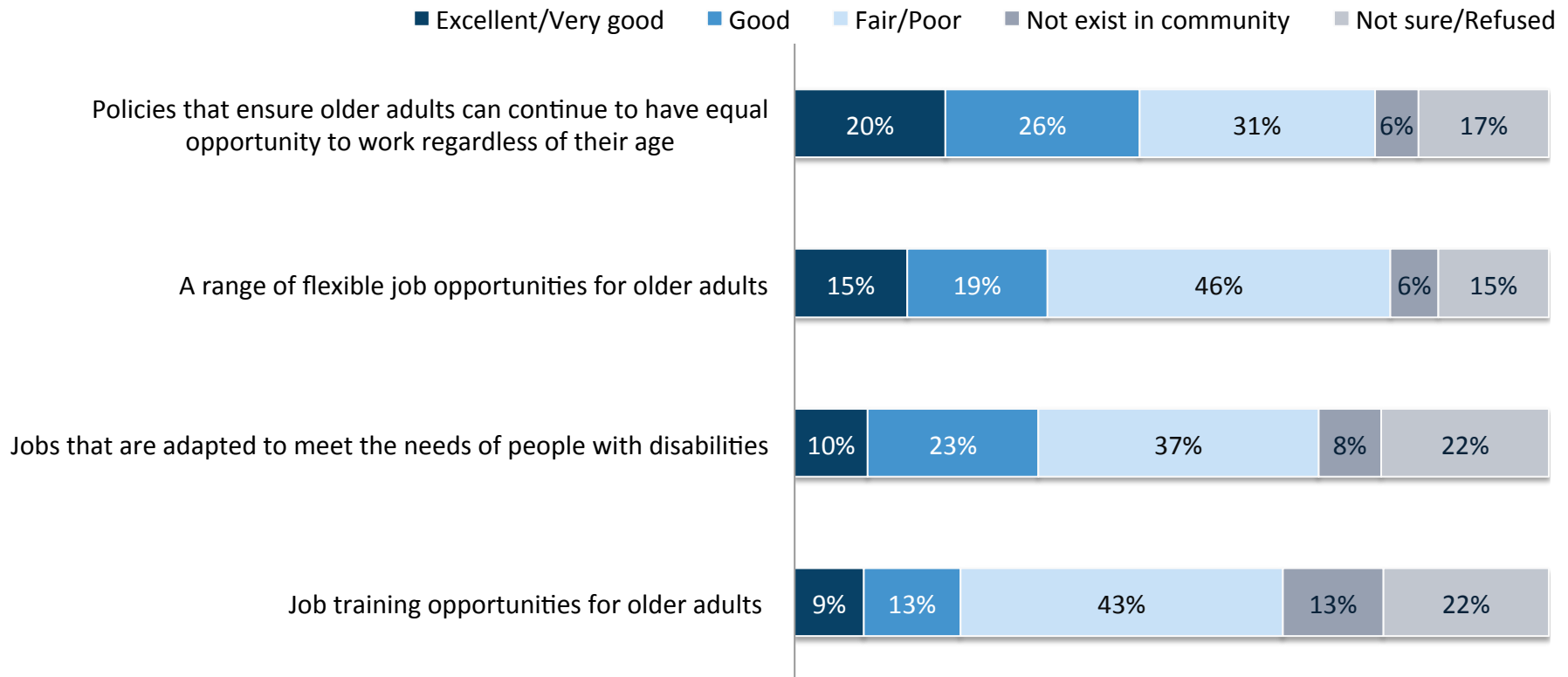

Larimer County residents age 50+ are somewhat divided in their opinions on how well their community is doing in terms of having employment opportunities for older residents.



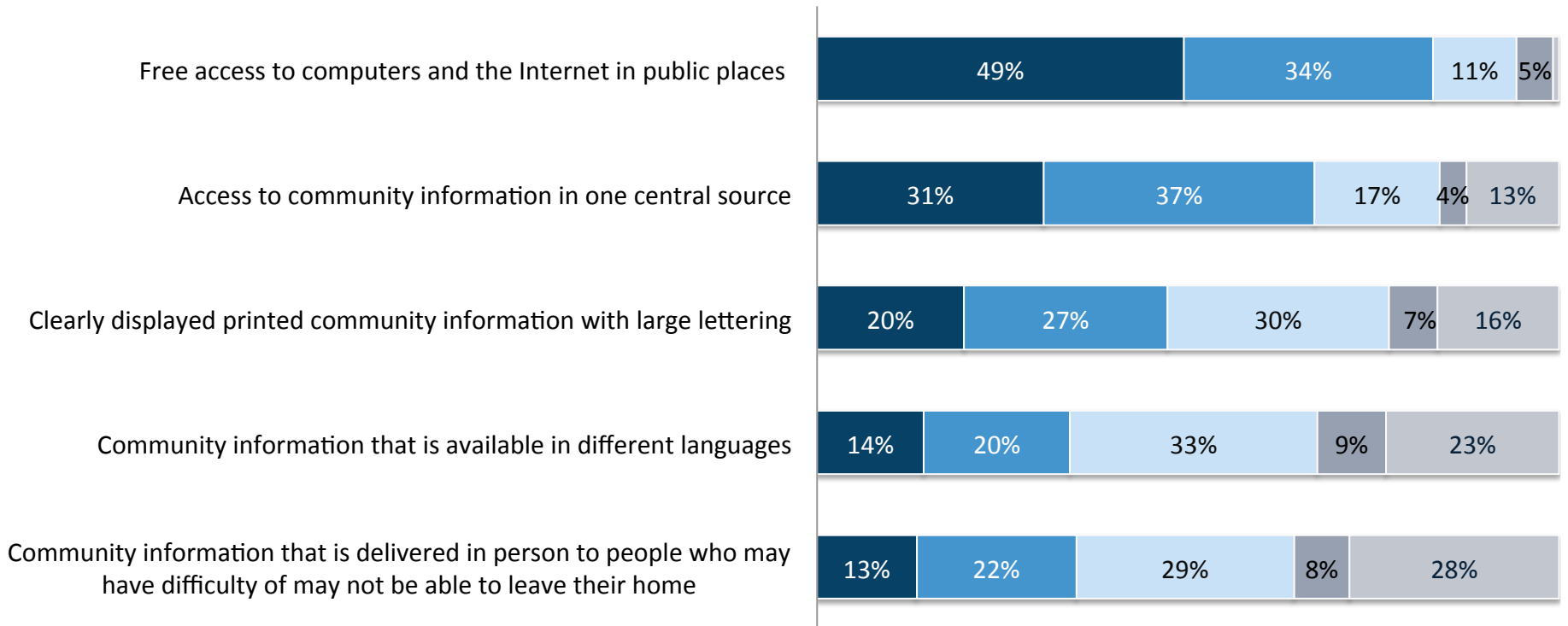

Survey Methodology:

- A telephone survey was commissioned by AARP to assess public opinion among Larimer County Residents Age 50+ about age-friendly and livable community topics in Larimer County outside of Fort Collins/Loveland.
- Telephone interviewing was conducted by Alan Newman Research from July 1st to 14th 2016.
- A total of 188 interviews were conducted. The margin of error for this sample is $\pm 7.3\%$.
- The sample utilized RDD landline and cell phone records.
- The data contained in this deck are based only on those respondents who live in Larimer County outside of Fort Collins and Loveland.
