Budget Update

Jarett Hughes provided the monthly budget update to Planning Group members. See link

Update from Janice Blanchard, Senior Advisor on Aging, Governor's Office

Janice Blanchard joined the Planning Group to provide an update on work efforts. Janice related progress and work back to the initial goals laid out in the 2016 Action Plan and included in each update. Efforts highlighted were as follows:

- Paid family leave for state employees
- Supporting the work of the Secure Savings Board/retirement security
- Participating and supporting in the Age-Friendly Workplaces Conference
- Age-friendly public health and age-friendly health systems
 - Working with Colorado Department of Public Health and Environment and Gabriel Kaplan to form a working group to explore opportunities
- Top priorities for 2020:
 - Implementing Planning Group recommendations
 - o Structurally integrate the Planning Group and Senior Advisor efforts



Jim Collins made the point that Area Agencies on Aging cannot continue on flat funding through State-Funding for Senior Services.

Jayla Sanchez-Warren noted that increasing provider capacity in rural parts of the state is an important goal for Denver Regional Council of Governments and the Colorado Association of Area Agencies on Aging. Trying to build up capacity prior to a significant increase in demand for services is a top priority for the Area Agency on Aging network. Jayla also suggested that supporting funding for additional nursing home ombudsmen is a need. The state spends a significant amount of money on nursing home care and it only makes sense to prioritize funding for paid positions to ensure quality of care and advocate for residents.

Karen B. expressed concerns over the Governor's priorities and the perception that aging is not one of them. Karen indicated the importance of "getting upstream" on health and aging issues by identifying and/or supporting the development of products and policies that support older Coloradans and older workers. Karen also expressed dismay over the Attorney General's office not prioritizing funding for the Financial Security Coalition efforts.

Update from Rich Mauro on Legislation

With extra time left in the meeting, Rich Mauro offered the group a brief update on from of the topics to expect during the legislative session. They included: efforts to modify the Senior Property Tax Exemption, renter's rights, prescription drug costs, loan forgiveness for geriatric medical providers, and increasing provider capacity for Area Agencies on Aging.
