# **Defining Our Transportation Challenges**



#### POPULATION BOOM

Colorado is the seventh fastest growing state. Total population is more than 5.7M, with 79,782 new residents in 2018\*. A majority of newer residents are moving to the metro areas. Population is expected to reach 7.8M by 2040. \*According to the Colorado Demography Office and U.S. Census Bureau



#### **VEHICLE MILES TRAVELED (VMT)**

2018 VMT in Colorado is expected to reach 50.5B, with 72.3B VMT expected by 2040. Population increases and technology enhancements will help drive VMT increases in future years.

On-demand vehicles may increase VMT in future years as vulnerable citizens, such as seniors, have greater access to mobility options.



#### VEHICLE AND AIR CONGESTION


Higher VMT on the highway system creates traffic congestion as vehicles become slow and inefficient, reducing travel times and increasing emissions. After a national fall of 8.1% in transportation-related emissions from 2005 to 2010, emissions have increased by 2.8% from 2010 to 2016, according to the EPA, as travel times have increased in Colorado and across the country. Inefficient vehicle movements help create "Congestion on the Road and Congestion in the Air".

### Office of Innovative Mobility / Division of Transit & Rail

- 2008 Intercity and Regional Bus Network plan developed
- 2009 DTR created by State Legislation
- 2014 Intercity and Regional Bus Network plan updated
- 2015 Bustang Express Bus Service began
- 2018 Outrider Rural Regional Bus Service began
- 2019 Statewide TDM Plan

SB 09-094 Creation of the Division of Transit and Rail

- Plan, develop, operate, integrate transit into the Statewide System
- Coordinate with other transit providers to plan, promote, and implement transit services statewide

### **Multimodal Connectivity**

- Front Range/I-25 Corridor
  - Bustang service
  - 10 mile spacing of Transit Stations/Mobility Hubs
  - Future Front Range passenger rail
- I-70 Mountain Corridor
  - Bustang Service
  - 30-mile spacing of Transit Stations/Mobility Hubs
- Rural Colorado
  - Outrider service
  - Partner Agency regional transit
  - Connection to Bustang
- Development of Mobility Hubs


### **Funding Sources**

- Utilize Senate Bill 267 funds for Strategic Capital Projects\*
  - 10% of total SB 267 to transit
    - 75% Non-Rural
    - 25% Rural
      - Counties with less than 50,000 pop.
- Additional funding source:
   Multimodal Options Fund
  - 15% of total SB 1 transit
    - 85% Local
    - 15% CDOT

<sup>\*</sup>SB 267 Funds may also be used for storage and maintenance facilities


