

# Medicaid Basics

- Created in 1965
- Health insurance for eligible low-income adults, children, pregnant women, elderly adults and people with disabilities
- Entitlement program currently covering nearly 70 million Americans nationwide
- States given the option to participate
  - Funded jointly with State and Federal Funding
  - Some mandatory requirements
  - Some flexibility for States to tailor their Medicaid program to their needs and population

Optional Benefits: PACE, case management


> Mandatory Benefits: Inpatient and outpatient hospital services, physician services, laboratory and x-ray services, more...

### Health First Colorado (Medicaid) Caseload and Expenditures




# LTSS Programs

- Home and Community-Based Services (HCBS) Waivers
  - Provide in-home and community supports like transportation, personal care, adult day care, assisted living
  - > Specific eligibility requirements
- Program of All-Inclusive Care for the Elderly (PACE)
  - > Capitated type program including Medicare
  - Individuals can live in any setting and receive all acute and long-term care services through this program
- Nursing Facilities
- Long-Term Home Health, Private Duty Nursing, Hospice



### Long Term Services and Supports Enrollment and Expenditures


