Update from Katherine Keegan, Office of Future Work (OFW)

- OFW partners with the Colorado Workforce Development Council and works across State Departments to work on policy and program solutions
 - Policy and program recommendations are intended for the 2021 legislation session and the goal is for them to be finalized in August of 2020
- Mature workers are a primary focus, but she is looking across the life course
- Statewide Regional Convenings
 - Pueblo 2/25
 - o Pikes Peak 3/6
 - Adams County/Broomfield 3/12
 - Jefferson County 4/7
 - o Larimer/Weld 4/8
 - o Boulder 4/30
 - To be scheduled Denver and Upper Arkansas
 - Expected audience 50-100 participants and she hopes to have Planning Group representatives participate when possible
 - National Conference planned for June 1 and 2 in Denver-area
- Digital literacy is a focus area
 - o What does "digital literacy" mean?
 - Workforce centers are behind, where are opportunities for collaboration? Possibly with public libraries
- Direct care workforce will also be a focus may be useful to connect Katherine with Brandon McReynolds, Department of Higher Education, and Emily Johnson, Colorado Health Institute

Update from Janine Vanderburg and Age-Friendly Workplace Initiative (AFWP) – Link to Slides

- AFWP Initiative headed by Karen Brown through Changing the Narrative focuses on the myths surrounding older workers with the goal of changing those perceptions
- Recently developed a Resource Guide for older workers



- Collaborating with Age-Friendly Foundation to administer a business certification
 - Opportunity for the state to adopt certification process?
 - Would be important to pick an office or agency that did not present "concern" for employers regarding state involvement
- Important to coordinate with and impact Workforce Development Centers
 - Furthermore, coordinate with economic development teams at the local level
 - Develop coordinator, liaison, and navigator positions to connect older workers with businesses
 - o Workforce Centers should offer this age-friendly training
- Those attending presentations are asking "where can they find older workers"?
 - Especially within the context of low unemployment rates

Colorado Workforce Development Council (CWDC) Reactions – Phil Nash
