Meeting Notes

Welcome, Roll Call, and Approval of Minutes and Agenda

- Meeting was called to order at 12:02 pm by Ed Leary
- Ed welcomed planning group members; Andrea Wilkins verified that there was a quorum.
- May minutes approved (motion to approve made by Christian Itin, seconded by Tony Tapia).
- June agenda approved (motion to approve made by Christian Itin, seconded by Karin Stewart).

Member & Staff Announcements:

Hayley Gleason lead a tribute to Chris Lee, recognizing his dedication and contributions to the health care field in Colorado.

Karen Brown shared information on Age Inclusive Management Strategies website launching and meeting.

Update From Jarett Hughes, Governor's Senior Advisor on Aging See Presentation Slides here.

- Overview of legislation that was passed during the 2021 legislative session impacting older adults including HB 1097, 1187, 1264, 1271, SB 118, 137, 146, 148, 158, 175, 181, 251, and 290. The Governor is expected to sign all bills and all will become law. Additional information can be accessed on these bills through the General Assembly website.
- More decisions over state spending, allocation regarding federal stimulus dollars to take place during interim. Workforce development funding will support adult education, upskilling and reskilling; a lot of housing-related investments expected; \$15 million set aside for AAA's – new grant program (via SB 290) to allow for infrastructure investments.
- More updates to come on interim activity, ARP allocations, and bill implementation.
- Updates on American Rescue Plan not all spending decisions will be made at once. Spending
 needs to be obligated by 12/31/24 and spent by 12/31/26. Interim committees will meet heavily
 in August and September; expect a lot of activity from committees dealing on behavioral health,
 workforce and affordable housing issues. Information on interim committees can be found here.
- SAPGA has submitted initial spending priorities, members are encouraged to continue sharing priorities with Jarett and House and Senate leadership and with your state legislative representatives and senators.
- Jarett working with CDOT Office of Innovative Mobility (pilot program) to investigate how program can support older adults. More information is forthcoming.
- Lifelong CO efforts continue, plan approved by Governor and AARP national office.
- AARP is conducting a meeting on July 14 on age friendly strategies on affordable housing from 10-12 pm.
- General fund money has been identified to support Jarett's position through July 1, 2022.

Elizabeth Mullins, Director, Division of Veteran's Community Living Centers (VCLC), CDHS See Presentation Slides here.

- Five VCLCs in CO Huerfano, Fremont, Rio Grande, Garfield, and Denver/Arapahoe counties.
- VCLC Needs Assessment report can be accessed here. Key questions explored include what are the health and long term care needs of CO veterans? How can VCLCs improve health care for the growing population of veterans? Are there enough VCLCs?
- Key take-aways of assessment: many veterans have long term health care needs that require long term support; VCLCs could expand services and adapt their care model to veteran's preferences and needs; no present need indicated for increased bed capacity within VCLC system.
- Veteran population is changing. There are many more female vets and vets who are people of color. Veteran population is getting younger.
- Vets have higher rates of chronic disease compared to the general population; different behavioral health needs, especially among vets who are female and POC.
- Future of long term services is uncertain COVID changed so much.
- In general vets have a preference to remain in their homes if possible.
- To create more age-friendly, vet-friendly communities, it is important to understand who vets are, and understand that there is a strong military culture. Important to monitor system capacity and respond accordingly; engage community partners and policymakers across the state.

- In trying to enhance equity and inclusiveness in age-friendly community efforts it is important to consider how we are engaging older adults and older adults of color. Engagement is difficult to measure but very important to understanding the impact and success of age-friendly planning.
- Breakout discussions: What are the challenges and barriers to full, inclusive community engagement? What has SAPGA done to engage older adults of color? What's missing from usual engagement efforts? What are the challenges to full participation? Equity will not happen unless we are strategic and intentional.
- Breakout group take-aways and report back: outreach must be intentional, need an inclusive
 approach to public participation, it is difficult to achieve meaningful participation and
 engagement especially if there is no pre-existing relationships with communities of color, tribal
 outreach requires a specific approach it is helpful to connect with those that have relationships
 in the community and can facilitate connections; past efforts have been met with mixed success,
 ongoing struggles with tokenism, need to acknowledge history and proceed with commitment to
 long term relationship building.
- NCL Better Aging Civic <u>Index</u> provides a framework for discussing and measuring a community's civic capital. BACI is intended to combat ageism, fight loneliness and isolation, encourages intergenerational collaboration, and infuses an equity lens into aging work.
- Community engagement is most effective when it is co-created community and older adults play an active role in shaping decisions and civic affairs.
- Helpful to explore use of BACI in other contexts in relation to implementation of specific legislation, implementation of Lifelong CO, etc.
